



## Ply-Trim® Limited Warranty

## Ply-Trim South, Inc. warrants Ply-Trim Medium Density Overlay (the "Trim") as follows:

- The trim meets or exceeds both government and industry standards pursuant to standard PS-1-83, for exterior use in residential or light commercial purposesprovided that the Trim is installed in accordance with established industry practice and standards.
- 2. There will be no structural failure or delamination of Trim for a period of ten (10) years from the date of manufacture, provided that: (A) the Trim has been installed in accordance with established industry practice and standards; (B) has been handled and stored at least four (4) inches above ground and protected under a roof from the elements; (C) finished, maintained, and used in a manner considered to be sound practice in the industry.
- The trim is primed using an acrylic water based sealer primer, which is applied to the face surface and two (2) edges. Ply-Trim South, Inc. warrants the sealer-primer for a one (1) year period from the date of application against blistering and peeling under normal conditions of use and exposure provided that (A) the Trim has been properly installed and maintained during the one (1) year period in accordance with established industry practice and standards. (B) Two (2) coats totaling not less that 1.5 mils dry thickness of an unthinned 100% acrylic latex exterior paint formulated for wood siding has been applied within ninety (90) days of installation of the trim. Oil base finishes are NOT recommended for topcoat and will void the warranty. (C) Weather conditions must be considered when making plans to paint. Avoid painting with water base latex paints in hot, humid weather or cool weather when the temperature is expected to fall below 50 degrees Fahrenheit (10 degrees Celsius) Postpone painting if fog, dew, rain, or frost is anticipated. Ply-Trim South, Inc. does not warrant this primed surface for peeling or mildew problems resulting from the breakdown of any topcoat paint film.

In the event the distributor and/or the purchaser of the structure to which the Trim is applied, notifies Ply-Trim South, Inc. in writing of claim, that the Trim fails to conform to the terms of this warranty, and if, after such notice, inspection by Ply-Trim South, Inc. personnel and/or an APA field representative confirms that the product has failedto meet the terms of this warranty, then Ply-Trim South, Inc. will within a reasonable time at its terms of this warranty, or refund to the owner,

and to repair or replace the amount of money reasonably necessary to repair or replace the nonconforming portion of the Trim including the usual and reasonable cost of the labor. The total financial liability of Ply-Trim South, Inc. hereunder, including costs of material and labor, shall not exceed two times the original sale price of that portion of the Trim determined not to conform with the terms of this warranty.

In no event shall Ply-Trim South, Inc. be liable to the distributor, the purchaser of the structure to which the Trim is applied or anyone else for personal injury or property damage, or for incidental and consequential damages however occasioned.

NO OTHER WARRANTY WILL BE MADE BY OR ON BEHALF OF THE MANUFACTURER OR THE SELLER BY OPERATION OF LAW WITH RESPECT

TO THE TRIM, OR ITS INSTALLATION, FINISHING, STORAGE, HANDLING, USE, MAINTENANCE, REPLACEMENT OR REPAIR. PLY-TRIM SOUTH, INC. MAKES NO WARRANTY WITH RESPECT TO INSTALLATION OF THE TRIM BY A BUILDER OR CONTRACTOR OR ANY OTHER INSTALLER, PLYTRIM SOUTH, INC. MAKES NO WARRANTY WITH RESPECT TO THE FINISH COATINGS APPLIED TO THE TRIM BY ANY BUILDER OR CONTRACTOR OR ANY OTHER PERSON, AND PLY-TRIM SOUTH, INC. WILL NOT BE RESPONSIBLE FOR ANY FAILURE OF THE FINISH COATINGS APPLIED TO THE TRIM. PLY-TRIM SOUTH, INC. SHALL NOT BE LIABLE BY VIRTUE OF ANY WARRANTY OR OTHERWISE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL LOSS OR DAMAGE RESULTING FROM THE USE OF THE TRIM. PLY-TRIM SOUTH, INC. MUST BE GIVEN A SIXTY (60) DAY OPPORTUNITY TO INSPECT THE TRIM BEFORE IT WILL HONOR ANY CLAIMS UNDER THE ABOVE WARRANTIES. THE ABOVE WARRANTIES APPLY ONLY IF THE TRIM HAS BEEN STORED, HANDLED, INSTALLED, PAINTED AND MAINTAINED IN ACCORDANCE WITH THE FOREGOING REQUIREMENTS, OR IF NOT ADDRESSED BY THE FOREGOING, IN A MANNER CONSISTENT WITH GENERALLY ACCEPTED BUILDING PRACTICES IN THE INDUSTRY, FAILURE TO FOLLOW HANDLING INSTALLATION AND FINISHING INSTRUCTIONS SHALL RESULT IN THESE WARRANTIES BECOMING NULL AND VOID.
